#### 9. Neighbourhood Plan

The Chairman of the NDP working party gave an update on the chosen Independent examiner for the Much Marcle NDP. On receipt of the examiner's report and with input from the appointed Planning Consultants, Foxley Tagg, to carry out final formatting, the final version of the plan would be submitted to Herefordshire Council in advance of the proposed date for the referendum om the 12<sup>th</sup> July 2018. A Parish Council meeting would need to be called to consider the Examiners report and the final version of the NDP. It was suggested that the Council meeting be set for Thursday 31<sup>st</sup> May 2018.

#### **RESOLUTION:** That the Parish Council set a meeting for the 31<sup>st</sup> May 2018 to consider the independent Examiners report and the final version of the Much Marcle NDP.
