36. Neighbourhood Plan: The Chairman of the Working Party entered the room.

36.1 The Chairman of the Neighbourhood Plan Working Party gave an update to Councillors and presented the report of the meeting held on the 13th June 2017. Herefordshire Council raised a challenge on a couple of areas: mainly with the allocation of developing redundant buildings and social housing. Once these have been addressed the draft plan should be ready for submission to Councillors at the September meeting. The Chairman also raised his concerns over the website and was informed that this being addressed by the Clerk and Councillor Barber-Starkey in accordance with the proposed deadline of the end of August 2017.
