3. Report of 18th October 2016

4. Regulation 14 Consultation

a) Parish Council Website:

The Chairman reported that the Parish Council website was now up to date and that he had forwarded his thanks to the Parish Clerk for her efforts in ensuring that all of the relevant documents relating to the Regulation 14 consultation, and all reports of the Working Party, are available to review and download.

d) Statutory Consultees:

e) Publication of NDP Post Regulation 14

S Tagg to be charged with the task of preparing a fully formatted NDP including maps and photographs after the necessary Regulation 14 consultations, and any subsequent amendments, had been completed prior to the Regulation 15 stage. The question of single or double columned presentation would be formally decided at that stage.

f) Habitats Regulations Assessment

g) Environmental Report
