**Ground breaking moment for cyber security in Hereford**

Work is due to start on the £9 million Cyber Quarter - Midlands Centre for Cyber Security in Hereford and was marked by an official ground breaking ceremony on Friday 7 June. Cllr David Hitchiner, Leader of Herefordshire Council, said: “We are very excited about this joint venture with the University of Wolverhampton, which is a key investment in creating more knowledge-based jobs in Herefordshire.

“The new Midlands Centre for Cyber Security is a fantastic facility which promises to attract new hi-tech investment, draw expertise and create high-income jobs in the County. It will create a range of opportunities in the growing cyber security sector in Herefordshire, which already has an established, highly regarded security industry.”

Andrew Manning Cox, chairman of Hereford Enterprise Zone and Marches LEP board member, said the new centre would further underline the zone’s position as a natural home for cyber security, business, research and innovation.

“Skylon Park has already been highlighted by the Government as having a crucial role to play in the growth of cyber research in this country and the new centre will put the zone firmly at the heart of this vital field.

“The national and international importance of the work which will be undertaken at the centre will act as a beacon of excellence, attracting still more investment at Skylon, the only Enterprise Zone in the country to focus on the defence and security sector.

“The result will be good news for Skylon Park, Hereford and the Marches region as a whole.”

The Cyber Quarter - Midlands Centre for Cyber Security is to open in summer 2020.

**Council recycling scheme generates £8k for charity**

The donation was possible thanks to a national metal recycling scheme that has allowed the Crematorium to donate over £70,000 to local charities since 2011.

The Institute of Cemetery and Crematorium Management (ICCM) launched their metal recycling scheme in 2005 as a way to recycle the metal recovered from cremated remains instead of burying them. Participating crematoria are asked to nominate a local bereavement charity to be given a share of surplus monies from the recycling process each year.

The service is provided at no cost to crematoria who have signed up to the scheme and metals are not recycled without the next of kin’s permission, which is sought at the time of the funeral arrangements.

Since November 2011, this scheme has so far raised £76,624 for local charities including the ELY Memorial Fund, The Haven, Cruse Bereavement Care, St Michael's Hospice, Sands –

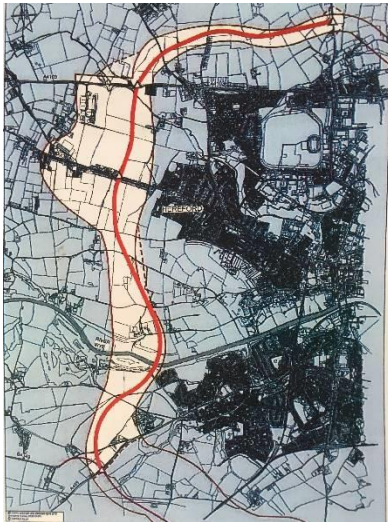

### **Hereford Bypass**

The new council is bedding in but the real concern is their thinking in cancelling the western



Hereford City bypass. The building of houses was predicated on a western highway which is the only side you can build a complete north to south route. It is also the core infrastructure project to deliver more sustainable transport solutions in the City and reduce the pollution levels in the streets.

The western bypass planning application was due to come to the planning committee in January 2020 and cancelling the project will mean millions of pounds of our money wasted with no alternative probably developed. Over the 23 years I have been a County Councillor we have worked on various transport alternatives including looking at going on the east of the city, park and ride and bus routes. We have a

challenge to deliver sustainable transport solutions for rural areas like Herefordshire, but the consequences to the growth of the local economy, delivery of services and impact on our residents needs to be clearly understood before cancelling the project without a developed alternative.

### **Don't let noise pollution be the sound of your summer**

Herefordshire Council's summer noise hotline opens today (Friday 21 June 2019). Noise officers from the council's Environmental Protection team will once again be out and about around the county on Friday and Saturday monitoring noisy summer hot spots and investigating noise complaints.

Herefordshire Council receives up to 1000 noise complaints a year, with a 50% increase over the summer months. Most summer noise complaints are about loud music, parties, barking dogs and loud factory equipment, so the council is urging residents and businesses to follow their top tips to make the summer enjoyable and prevent noise nuisance occurring in your neighbourhood.

Herefordshire Council's out of hours noise team will be available on 01432 261761 9pm to 2am every Friday and Saturday evening from 21 June until the end of August, and on August bank holiday Sunday.

Top tips for limiting summer noise

Parties and gatherings

Always be respectful towards your neighbours and their family, particularly if they have to get up for work the next day. Neighbours are less likely to have a problem with a party if they know about it in advance and what time it will finish. Remember noise from the garden travels further, so make plans to go inside later in the evening and encourage your guests to keep their voices down.

Stereos and TVs

Position the TV and speakers away from your neighbour's wall – raised off the floor if possible. Keep the volume low as bass frequencies carry further, or use headphones if you like your music loud.

Dogs

Constant barking or whining from a dog can be disturbing to neighbours, especially in the summer when people (and dogs) spend more time outside. Dogs may bark because they are lonely or unhappy; if you are going away and your dog is being checked on by a dog sitter, leave a contact number with your neighbours just in case of problems.

DIY

Don't mow your lawn or start DIY too early or late - you may be an early riser or a night owl, but others may not be! Noisy DIY activities should be kept to a minimum amount of time, or pre-warn neighbours about lengthy DIY work. When buying new power tools, look for the Quiet Mark Award which can help you choose quieter equipment.

Cars

Make sure the music in your car isn't disturbing others when you are parked up or waiting for someone. Check that your car alarm works properly and if not, get it mended quickly. Be considerate when carrying out car repairs and make sure you don't start your work too early or too late.

Alarms

Leave a house key and contact number with a neighbour - they can contact you if the house alarm goes off while you are away.

Businesses

Regularly monitor and maintain noisy equipment that can be heard from outside your premises, especially if they operate through the night. When there is less traffic on the roads, low frequency and machinery noises can become louder.

**Preventing pollution and hazards from soil water run-off**

Heavy rain in Herefordshire last week led to a number of pollution incidents caused by soil running off into rivers and large quantities of mud washing onto the county's roads resulting in hazardous driving conditions.

With a lot more rain forecast the Environment Agency with Herefordshire Council are continuing to target landowners to remind them of their responsibilities.

In heavy rain, soil can be dramatically washed away from fields. Better soil management can help reduce instances of soil loss which causes water pollution, exacerbates flooding and creates dangerous conditions on the county's roads.

Satellite imagery and footage from drones is used to identify bare, sloping agricultural fields where soil run-off is most likely. With this intelligence, the Environment Agency will visit the landowner to make them aware of the potential issues and guidance on better soil management practices.

This is particularly important for the River Wye; one of the biggest threats to this special area of conservation comes from run-off from agriculture. Herefordshire's famous sandy red soils are generally very fine and become extremely mobile during heavy rain storms, meaning it is not unusual for soil and sediment enter watercourses and harm the delicate gravel ecosystems.

Clive Hall, Herefordshire Council's Acting Assistant Director Highways and Transport, said:

“Anyone with concerns of excessive mud on the road that is presenting a hazard to road users should call Balfour Beatty Living Places on 01432 261800 (calls are monitored 24/7). They will assess the risk and take the action required to return our roads to as safe a state as we can.”

Environment Agency staff respond to pollution incidents 24/7 to contain pollution and protect water quality. They investigate pollution incidents to find the source, stop the problem and

**Station Approach car park to close**

**Hereford car dealer jailed for forgery and unfair trading**

A Hereford car dealer has been jailed for 20 months in a case taken to Worcester Crown Court by Herefordshire Council's Trading Standards team.

Mr Kenneth Leach-Smith (59) from Rose Cottage, Kington traded as Halt Garage on Kings Acre Road, Hereford. Two weeks before the scheduled trial in May, Mr Leach-Smith pleaded guilty to three counts of forging service histories, one count of fraud for falsely claiming a car

received a cam belt change and three unfair trading offences for falsely advertising multiple vehicles and selling two cars which had previously been written off. The offences took place between August 2016 and July 2017.

Sentencing took place at Worcester Crown Court on 13 June 2019; His Honour Judge Cole sentenced Mr Leach-Smith to a term of 20 months imprisonment.

The court heard that Trading Standards officers visited Halt Garage in May 2017 after receiving a complaint and discovered a number of forged service records as well as many vehicles being falsely advertised as having full service histories. A thorough investigation followed and found further forgeries, such as the sale of a clocked car and insurance write offs, and false advertising where the trader claimed all cars were HPI clear. Signage displayed around Halt Garage falsely claimed that money was donated to a local children's charity which was in fact dormant.

The garage has been under reputable new ownership since July 2018.
