Dear Parish Councillors and Residents

I believe that we should still be proactive in ensuring the safety and wellbeing of our parishioners; and by us all becoming NICE NOSEY NEIGHBOURS. I am well aware that there is already a great development of support network of friends and neighbours looking after their immediate community, informally within streets, hamlets and pockets of houses including Whatsapp and telephone contacts.

This is valuable and the council has a corvid-19 talk community (see previous ward reports) but it would be helpful to continue to feed these activities to our parish/community contacts so we can identify anyone or anywhere which may be falling through the net, and for people to know where to go if there are specific problems.

With this ongoing pandemic I have included in this ward report a lot of information from different areas. I appreciate that this ward report is considerably longer than previous but the information you are seeking may be included in this document.

I shall continue to keep you updated in my monthly report and also as and when information is available. As usual I remain available by email and telephone to assist you further when required.

A big thank you to everyone for looking out for your neighbours, our community lead contacts, and the huge amount of random acts of kindness that are being done in our communities. If you can offer some support, are in need or know someone who is in need please feed into them.

Coming out of lockdown

This month, will see the phased return of some of our school pupils and reopening of some shops although we will have to wait until next month probably for a haircut.

The safety of pupils and staff is at the forefront of planning for a phased return to education, following the Government's announcement that schools may re-open for primary school children in Reception, Year 1 and Year 6 from 1 June - possibly followed by secondary school children in Years 10 and 12 later in the year.

With further Government announcements expected over the next few days, Herefordshire Council is working closely with schools, colleges and early years settings to plan for the potential re-opening of schools to enable more children and young people to continue their education in a safe classroom environment.

Since the lockdown in March, Herefordshire schools have collectively continued to support and educate children and young people across the county, including 800 children of the county's key workers and vulnerable children. This work has been carried out in an ever changing environment with schools, colleges and settings demonstrating their flexibility and commitment by adopting new ways of educating, keeping in touch and supporting their

pupils virtually. Many of the schools have remained open during the school holidays for children of key workers and have supported families by distributing food or vouchers.

Shops to reopen

I am sure we are welcoming the reopening of shops, regardless of what they sell. However, they will only be able to open with social distancing measures in place. Car showrooms and outdoor markets can reopen from 1 June. Non-essential shops can reopen in England from 15 June if they meet guidelines to protect staff and shoppers. Retailers will have to comply with new guidelines to protect shoppers and workers.

All of this is conditional on the government's five tests for easing lockdown being met by these dates. It is important and I am sure you will agree, that local businesses have been supporting their communities throughout lockdown with home deliveries; where they can. It is therefore important that now we support our local businesses.

£50 million boost to support the recovery of our high streets

Councils across England are to share £50m of additional funding to support the safe reopening of high streets and other commercial areas. The money will allow local authorities in England to put in place additional measures to establish a safe trading environment for businesses and customers, particularly in high streets, through measures that extend to the end of March 2021. This funding comes on top of the Government's comprehensive package of support for business and workers during the economic emergency. The Reopening High Streets Safely Fund will help councils in England introduce a range of safety measures in a move to get people back to work and customers back to the shops. Councils will also be able to use this money to develop local marketing campaigns to explain the changes to the public and reassure them that their high streets and other commercial areas are safe.

Life Under Lockdown - Talk Community telephone support

The Talk Community Covid-19 response has received over 3000 telephone calls since the commencement of the service 7 weeks ago. Herefordshire Council (HC) have deployed over 40 council staff to support the telephone service and vulnerable people of Herefordshire and at its peak were receiving 180 calls a day. The infrastructure has enabled over 1500 requests for support for the most vulnerable people with the main areas of support continuing to be for supplies and medication collection. The numbers of calls has significantly reduced to an average of 50 per day over the past few weeks, which indicates that the needs of the vulnerable are being met either in the communities, through the Talk Community response or within their own networks. Over the past few weeks HC have been planning for the next phase of the Talk Community Covid response and considering the future and sustainable model during this next stage. The telephone service has been available 7 days a week 8am-8pm during the weekdays and 10am-4pm on the weekend, however the numbers of call have significantly reduced over the weekend and out of hours therefore to provide a permanent offer for the vulnerable residents of Herefordshire we will be looking to reduce the hours over the next week. The weekend of the 16th/17th May will be the last weekend that the telephone support will be open and from the week commencing the 25th May, the bank holiday will be open10am-4pm and from 26th May the telephone service will be available 9am-5pm Monday to Friday with the Blueschool House staff providing the telephone support. This enables a permanent infrastructure at a time when

staff are being redeployed to substantive posts and to continue to meet the demand albeit at a reduced number. Out of hours support through Adult Social Care service remains available as well as the NHS 111 service, however the nature of the small amount of calls out of hours has not, in the majority of cases, required an urgent response."

Quitting smoking

This is one of the best ways to protect yourself and others and reduce your need to use the NHS; with smokers being at greater risk of developing life-threatening respiratory complications from COVID-19, there's never been a more important time to stop smoking.

Smoking severely damages your lungs and weakens your immune system and puts you at greater risk of developing respiratory disease. If you smoke indoors or in a vehicle it exposes those around you, particularly children, to increased risks from second-hand smoke.

Fortunately there's a huge range of free advice, support and quitting aids available for those who want to stop smoking to improve their health and stay out of hospital.

Throughout May and June Herefordshire's Stop Smoking Service is offering free personal support to all residents registered with a GP practice in Herefordshire, to help them on their journey to quit smoking for good. - There is different legislation and guidance in place in Wales, please respect it.
- Please continue to keep washing your hands. This is a vital part of reducing the risk of infection.
- If you are displaying symptoms of coronavirus, it is vital that you self-isolate for seven days and order a test immediately. If you test positive for coronavirus, you must share information promptly about your recent contacts through the NHS test and trace service to help alert other people who may need to self-isolate. If you have had close recent contact with someone who has coronavirus, you must self-isolate if the NHS test and trace service advises you to do so. If someone you live with is feeling unwell or displaying symptoms, please self-isolate for 14 days.
- Some people might not display symptoms so social distancing and hand washing remains vital. You can wear a face covering when out, to protect other people when you may be asymptomatic.
- Facilities such as waste & recycling centres, outdoor sports clubs, and outdoor retail outlets such as garden centres are now starting to reopen.
 Please follow the social distancing instructions and directions regarding entry and queuing, be aware that they might be busy, and try to avoid peak times.
- Hereford and Leominster waste and recycling centres are open for essential
 waste that can't be stored safely. Please only visit if it is absolutely necessary
 and be prepared for queues.
- West Mercia Police will continue to engage with the public, explaining and encouraging people in relation to the guidance and social distancing, and will only take enforcement action where it is absolutely necessary - when there are clear breaches of the restrictions, predominantly people gathering in large groups.
- Please be responsible and continue to work with us. We all still find ourselves
 in very challenging circumstances and we appreciate that the public has
 responded so positively to the extraordinary restrictions placed upon them.
 Remember that if you need our help we are here for you.
- The NHS are still available and services continue. Please do not delay in seeking medical attention, should you need it.
