2. Declarations of interest

J Finnigan and J Gibbon declared an interest in relation to the Local Green Space.

3. Report 17th February 2016

The report was accepted.

4. Amended Settlement Boundaries

Rushall

The boundary of the orchard by the cross-roads was considered in some detail. Its protected orchard status, possible designation as a local green space and open space nature were referred to. In conclusion was decided to exclude the orchard from the settlement boundary by moving the boundary to the road.

The amended map was accepted.

Much Marcle

The shop, Brookside Cottage and garage were included in the settlement area, but it was decided that the new garages at Walwyn Court should be excluded from the area.

5. Local Green Space Boundary

It was pointed out that the Bartons was included because of its recreational value whereas the Church, Mortimer's Castle and its environs were included because of their cultural and historical significance. It was decided that the immediate gardens of Swan Cottage and Lower Lodge should lie outside the local green space, but that the field and copse should lie within it.

The importance of Monks Walk in terms of its historical interest and recreational use for the health of the local community as a walking area was recognised by designating it as a local green space. The areas on each side of the road up to the new fences from Dymock Road to Hellens to be

included.

Neighbourhood Plan Project Time Line

The Chairman indicated that up to the end of March the group was about two weeks behind schedule, he intended to begin to tackle a draft plan at the earliest opportunity and would seek comments at each stage of the process.
